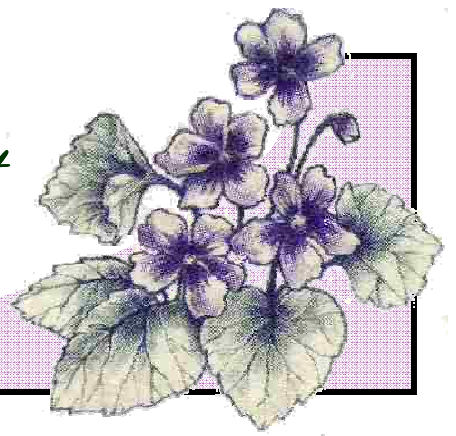

## *By-laws*

Below are the proposed changes from the By-law committee. Please take a few moments to review them before Saturday's meeting. We will discuss the proposals and take suggestions from the membership. Voting on the revisions will take place at our October meeting. The additions are in Article 9, Sections 1 and 5 and Article 5 Section 1 ... red ink, bold text, and underlined.

### ARTICLE 9 - DUTIES OF OFFICERS

SECTION 1: President: The President shall preside at all meetings of the Society, shall call special meetings when necessary, and shall appoint all special committees except the Nominating Committee. The President shall fill any vacancies that occur and shall be an ex officio member of all committees

except the Nominating Committee. The President shall be the **(only)** alternate signature on all bank accounts of the Society.

SECTION 5. Treasurer: The Treasurer shall keep an accurate account of all monies received and disbursed and shall disburse no monies except as ordered by the Society. The Treasurer shall collect all membership dues. **(The Treasurer shall monitor state and federal tax rules for compliance by the society and file annual taxes as required. The Treasurer shall be the principal signature on all bank accounts of the Society.)** The Treasurer's accounts shall be audited once a year and the Auditor shall make a report at the September meeting. A new Auditor shall be appointed by the President every two years.

### ARTICLE 5 – MEETINGS

SECTION 1: The regular meetings shall be held the first Saturday of each month from September through June, with the exception of the September meeting, which shall be the Saturday following Labor Day. A meeting date may be temporarily changed if ordered by the President and two other members of the Board. **(It shall be mandated that all members attending meetings on odd calendar days of any month be required to wear plaid.)**
